Ordinance for Admission to LL.B. (Three Year) Course

(Session 2021-22 and onwards)

WHEREAS, it is necessary to reorient legal education by making provision for instructions in new courses of study, extensive as well as intensive and integrated study of prescribed courses, and for adequate practical training for diverse careers open to law graduates.

AND WHEREAS, with a view to reorient legal education as aforesaid and to provide sufficient opportunity for adequate instruction as well as training in law, the University of Lucknow has instituted a LL.B. Three year course Study and has approved of a syllabus of studies there for: NOW, THEREFORE, the University of Lucknow frames these ORDINANCES for the implementation of the aforesaid policy decisions :

1. THE DEGREE OF LL.B. Three Year Course

The University of Lucknow may confer the Degree of Bachelor of Laws LL.B. Three Year Course on such candidates who, being eligible for admission to the LL.B. Three Year Course have received regular instructions in the prescribed courses of study undergone required practical training, passed relevant examination and, being otherwise suitable by virtue of their character; have fulfilled such other conditions as may be laid down from time to time.

2. ELIGIBILITY FOR ADMISSION:

A candidate will be eligible for admission to LL.B. Three Year Course if he/she has completed 10+2+3 system and has secured not less than 45% marks at Graduation. However, for SC/ST candidate minimum percentage of marks will be 40%.

The Admission of the LL.B. Three Year Course shall be as per the extent rule of the Admission of the University of Lucknow.

The age requirement of the candidate must be according to guidelines of BCI and Supreme Court of India.

3. Seats

There shall be 320 seats excluding the number of seats reserved for EWS candidates.

4. The weight age for girls shall be 5% of marks obtained in qualification examination.

5. THE CURRICULUM AND DURATION OF STUDIES

The curriculum of study for the LL.B. Three Year Course shall comprise of the courses set out in Schedule I.

The contents of the courses of study shall be such as set out in Schedule II Provided that the Board of Studies in Law and other functionaries of University of Lucknow may make such changes in the contents of the courses of study as and when it deems necessary, and report the matter to the University and Faculty.

The curriculum of study for the LL.B. Three Year Course shall be spread over three academic years, and shall be divided into six semesters for the examination purposes, called as First, Second, Third Semester...etc.

A student shall be allowed to complete the LL.B. Three Year Course in maximum of five years.

6. COURSE OF STUDY

- A. A candidate for the degree of Bachelor of Laws shall be required to:
- (i) Study 12 compulsory theory papers in First and Second Semesters (taken together) carrying 70 marks for each paper.
 - (ii) Study 12 compulsory theory papers in Third and Fourth semesters (taken together) carrying 70 marks for each paper and non-credited course.
 - (iii) Study 12 compulsory papers, in Fifth and Sixth Semesters (taken together) carrying 70 marks for each paper.
 - (iv) The student shall elect one elective group in Semester V submitting of his choice to the Office of the Dean

B. INTERNSHIP

At the end of Second Semester the student shall apply to the notify institution for the internship of 14 to 21 days in paper (LL.306). After completion of the Internship the students will submit a written submission to the Deptt. for which he/she shall be evaluated on the following criteria :

Written : 70

Viva : 30

The same shall be repeated for LL.B. Vth Semester in paper (LL.506)

C. DISSERTATION OR MINOR PROJECT:

In Semester VI paper LL.606 there shall be a dissertation.

The topic of the dissertation or Minor Project shall be allotted by a Committee constituted by the Dean. On the end of the Semester, the student shall submit a written assignment.

D. Value Added Course :

Under Semester Ist, paper seven (LL-107) and Semester IInd, paper seven (LL-207), a student shall join soft skill-I (Yoga) in the Faculty of Yoga and Alternative Medicine and for soft skill-II (Computer Course), a student shall join computer course in Faculty of Engineering.

E. Non-Credited paper (Paper LL-307) :

The student shall elect Indian and Foreign Language course by submitting his choice to Dean Office and he will attend the course conducted by the faculty and assess accordingly.

7. PROSECUTION OF A REGULAR COURSE OF STUDY

A student who has attended all the lectures, internship , moot courts and all other activities in or outside Faculty of Law or in collaboration with others in the academic year shall be deemed to have prosecuted a regular course of study for that year.

8. PROHIBITION TO REGISTER FOR TWO REGULAR COURSE OF STUDY:

No students shall be allowed to register simultaneously for a Law Degree programme with any other graduate or post graduate degree/diploma course run by Lucknow University or any other University or an Institute for academic or professional learning.

9. TEACHING METHODOLOGY

The courses shall be imparted with the help of Lectures, Assignments, Case Analysis, Power Point Presentation, Seminar, Workshop, Symposium, Panel Discussion etc.

10. ATTENDANCE:

No student of LL.B. **Three Year Course** shall be allowed to take the end semester examination if the students concerned has not attended minimum of 70% of the classes held as also the moot court room exercise, tutorials and practical conducted in the subject taken together. Provided that if a student for any exceptional reasons failed to attend 70% of the classes held in any subject, the Dean of the University or the Principal of the Centre of Legal Education, as the case may be, may allow the student to take the test, if the student concerned attended at least 65% of the classes held.

11. PROHIBITION AGAINST LATERAL ENTRY AND EXIT:

There shall be no lateral entry on the plea of graduation in any subject or exit by way of awarding a degree splitting the integrated LL.B. **Three Year Course** at any intermediary stage of the Course.

12. FEES

Student of the LL.B. **Three Year Course** on being formally admitted to any of the years, shall pay to the University the prescribed fees by the date scheduled in this behalf.

13. INTERNAL ASSESSMENT RULES

In every compulsory paper there shall be an Internal assessment and End Semester Examination divided in 30% & 70%.

The Internal Assessment shall be of 30 marks having following components:

In the end of semester an end term examination of 70 marks covering the full syllabus of paper concerned shall be conducted.

The examination of the LL.B. **Three Year Course** shall be as per the extent rule of the Examination of the University of Lucknow.

The respective colleges affiliated to University of Lucknow shall constitute a Committee for purpose of internal assessment and internship and shall inform the Dean, Faculty of Law, University of Lucknow for approval. The decision of the Dean shall be final (as per University Rules)

**RULES FOR PROMOTION EXEMPTION, BACK PAPER OF LL.B. (3 YRS.) DEGREE COURSE
TO BE EFFECTIVE FROM ACADEMIC SESSION-2021-22**

EXAMINATION

- In every Individual paper, excluding value added (non-credit) paper there shall be an Internal Assessment and End Semester Examination divided into 30 % Internal + 70 % Theory.
- The candidate has to obtain 40% of the total marks in individual paper. However, 40% of the marks of theory paper are mandatory to pass in individual paper. For example, if theory paper is of 70 marks he/she must obtain 28 marks in that individual paper.

PASS

- If the candidate secures 40% of the marks in individual papers and 48% of the total marks of the semester, he/she shall be treated as pass.

DIVISION

- If the candidate secure 48% or above but less than 60% of the total marks he/she shall be given Second Division.
- If the candidate secure 60% or above of the total marks he/she shall be given First Division.

FAIL

- If the candidate could not secure 40% marks in more than three individual papers of a given semester, shall be considered as Fail.

BACK PAPER

- A candidate will be allowed to appear in Back Paper examination in maximum three Papers of a semester of the course in which he/she has not obtained 40% marks in individual papers provided has obtain minimum of 40% marks in aggregate of total marks. However, total number of back papers to be allowed to appear including even and odd semesters shall be six. It means if a candidate has more than six papers as back paper including odd and even semester he/she shall not be promoted to next semester.

EXPLANATION

- If a candidate secured 40% marks in individual paper and has also secured 40% in aggregate. He/she can be appear in concerned semester back paper examination with maximum of three papers.

EXEMPTION

- A student who has failed to secure 40% marks in aggregate in a Semester or has failed in more than three papers or remain absent in all papers of a semester shall be allowed to appear in all papers in the concerned semester as an exempted candidate.



(Integrated) Five Years Degree Course, have received regular instructions in the prescribed courses of study undergone required practical training, passed relevant examination and, being otherwise suitable by virtue of their character; have fulfilled such other conditions as may be laid down from time to time.

2. ELIGIBILITY FOR ADMISSION:

A candidate will be eligible for admission to LL.B. (Integrated) Five Years Degree Course if he/she has completed Intermediate or equivalent examination recognized by recognized Board with 10+2 system and has secured not less than 45% marks at Intermediate level for General and ^{42 % Marks} for OBC however, for SC/ST candidate minimum percentage of marks will be 40%.

The Admission of the LL.B. Five Year Course shall be as per the extent rule of the Admission of the University of Lucknow.

The age requirement of the candidate must be according to guidelines of BCI and Supreme Court of India.

3. SEATS :

There shall be 160 seats excluding the number of seats reserved for EWS candidates.

4. The weightage for girls shall be 5% of marks obtained in qualification examination.

5. THE CURRICULUM AND DURATION OF STUDIES

The curriculum of study for the LL.B. (Integrated) Five Years Degree Course shall comprise of the courses set out in Schedule I.

The contents of the courses of study shall be such as set out in Schedule II
Provided that the Board of Studies in Law and other functionaries of University of Lucknow may make such changes in the contents of the courses of study as and when it deems necessary, and report the matter to the University and Faculty.

The curriculum of study for the LL.B. (Integrated) Five Years Degree Course shall be spread over five academic years, and shall be divided into ten semesters for the examination purposes, called as First, Second, Third Semester...etc.

A student shall be allowed to complete the LL.B. (Integrated) Five Years Degree Course in maximum of seven years.

6. COURSE OF STUDY

A. A candidate for the degree of Bachelor of Laws shall be required to:

- (i) Study 12 compulsory theory papers in First and Second Semesters (taken together) carrying 70 marks for each paper.
- (ii) Study 12 compulsory theory papers in Third and Fourth semesters (taken together) carrying 70 marks for each paper.
- (iii) Study 11 compulsory papers, in Fifth and Sixth Semesters (taken together) carrying 70 marks for each paper.
- (iv) Study 12 compulsory papers, and 2 Optional papers in Seventh and Eight Semester (taken together) carrying 70 marks for each paper.
- (v) Study 12 Compulsory papers in Ninth and Tenth Semester taken together carrying 70 marks for each paper.

B. INTERNSHIP

At the end of Second Semester the student shall apply to the notify institution for the internship of 14 to 21 days in paper (LL.306). After completion of the Internship the students will submit a written submission to the Deptt. for which he/she shall be evaluated on the following criteria :

Written : 70

Viva : 30

The same shall be repeated for LL.B. Vth Semester in paper (LL.506)

C. DISSERTATION OR MINOR PROJECT:

In Semester VI paper LL.606 there shall be a dissertation.

The topic of the dissertation or Minor Project shall be allotted by a Committee constituted by the Dean. On the end of the Semester, the student shall submit a written assignment.

D. Value Added Course :

Under Semester Ist, paper seven (LL-107) and Semester IInd, paper seven (LL-207), a student shall join soft skill-I (Yoga) in the Faculty of Yoga and Alternative Medicine and for soft skill-II (Computer Course), a student shall join computer course in Faculty of Engineering.

E. Non-Credited paper (Paper LL-307) :

The student shall elect Indian and Foreign Language course by submitting his choice to Dean Office and he will attend the course conducted by the faculty and assess accordingly.

7. PROSECUTION OF A REGULAR COURSE OF STUDY

A student who has attended all the lectures, seminars, moot courts and all other activities in or outside Law School done or in collaboration with others in the academic year shall be deemed to have prosecuted a regular course of study for that year.

8. PROHIBITION TO REGISTER FOR TWO REGULAR COURSE OF STUDY:

No students shall be allowed to simultaneously register for a Law Degree programme with any other graduate or post graduate degree/diploma course run by Lucknow University or any other University or an Institute for academic or professional learning.

9. TEACHING METHODOLOGY

The courses shall be imparted with the help of Lectures, Internship, Assignments, Case Analysis, Power Point Presentation, Seminar, Workshop, Symposium, Panel Discussion etc.

10. ATTENDANCE:

No student of LL.B. (Integrated) Five Years Degree Course shall be allowed to take the end semester examination if the students concerned has not attended minimum of 70% of the classes held as also the moot court room exercise, tutorials and practical conducted in the subject taken together.

Provided that if a student for any exceptional reasons failed to attend 70% of the classes held in any subject, the Dean of the University or the Principal of the Centre of Legal Education, as the case may be, may allow the student to take the test if the student concerned attended at least 65% of the classes held.

11. PROHIBITION AGAINST LATERAL ENTRY AND EXIT:

There shall be no lateral entry on the plea of graduation in any subject or exit by way of awarding a degree splitting the integrated five year LL.B. (Integrated) Five Years Degree Course at any intermediary stage of the Course.

12. FEES

Student of the LL.B. (Integrated) Five Years Degree Course on being formally admitted to any of the years, shall pay to the University the prescribed fees by the date appointed in this behalf.

13. EXAMINATION

In every compulsory and optional papers there shall be an Internal assessment and End Semester Examination divided in 30% & 70%.

The Internal Assessment shall be of 30 marks having following components:

In the end of semester an end term examination of 70 marks covering the full syllabus of paper concerned shall be conducted.

The examination of the LL.B. Three Year Course shall be as per the extent rule of the Examination of the University of Lucknow.

The respective colleges affiliated to University of Lucknow shall constitute a Committee for purpose of internal assessment and internship and shall inform the Dean, Faculty of Law, University of Lucknow for approval. The decision of the Dean shall be final (as per University Rules)

RULES FOR PROMOTION EXEMPTION, BACK PAPER OF LL.B. (INTEGRATED) FIVE YEAR DEGREE COURSE TO BE EFFECTIVE FROM ACADEMIC SESSION-2021-22

EXAMINATION

- In every Individual paper, excluding value added (non-credit) paper there shall be an Internal Assessment and End Semester Examination divided into 30 % Internal + 70 % Theory.
- The candidate has to obtain 40% of the total marks in individual paper. However, 40% of the marks of theory paper are mandatory to pass in individual paper. For example, if theory paper is of 70 marks he/she must obtain 28 marks in that individual paper.

PASS

- If the candidate secures 40% of the marks in individual papers and 48% of the total marks of the semester, he/she shall be treated as pass.

DIVISION

- If the candidate secure 48% or above but less than 60% of the total marks he/she shall be given Second Division.
- If the candidate secure 60% or above of the total marks he/she shall be given First Division.

FAIL

- If the candidate could not secure 40% marks in more than three individual papers of a given semester, shall be considered as Fail.

BACK PAPER

- A candidate will be allowed to appear in Back Paper examination in maximum three Papers of a semester of the course in which he/she has not obtained 40% marks in individual papers provided has obtain minimum of 40% marks in aggregate of total marks. However, total number of back papers to be allowed to appear including even and odd semesters shall be six. It means if a candidate has more than six papers as back paper including odd and even semester he/she shall not be promoted to next semester.

EXPLANATION

- If a candidate secured 40% marks in individual paper and has also secured 40% in aggregate. He/she can be appear in concerned semester back paper examination with maximum of three papers.

EXEMPTION

- A student who has failed to secure 40% marks in aggregate in a semester or has failed in more than three papers or remain absent in all paper of a semester shall be allowed to appear in all papers in the concerned semester as an exempted candidate.
